



Midstate Aesthetics Membership Contract

This Membership Agreement ("Agreement") is entered into by and between **Midstate Aesthetics** and the undersigned **Member** _____, effective on the date of signing. The Member agrees to the terms and conditions outlined below.

1. Membership Options and Monthly Contributions

(select one of the below options)

Essential Glow

Monthly contribution: \$125

Member receives **10% off Dysport, laser treatments, facials, and medical-grade skincare.**

Ultimate Radiance

Monthly contribution: \$195

Member receives **15% off Dysport, laser treatments, facials, and medical-grade skincare.**

• Midstate Money Account:

Each month, on the (1st) first of the month, the Member's contribution will be added to their Midstate Money Account, which can be used toward any product, injectable, laser treatment, or facial service at Midstate Aesthetics. Every dollar in your account is yours to spend.

- **Every dollar added is available for use.** If the service cost exceeds the account balance, the Midstate Money will be applied, and the Member is responsible for the remaining balance.
- **Additional Savings:** Discounts from membership pricing **cannot** be combined with other promotional offers or session/package pricing, the most favorable pricing will be honored. **Membership only valid at MidState Aesthetics location, 3210 SW 33rd Road, Suite 102, 34474.** Latisse not included.

2. Fees and Billing

- **Setup Fee:** A one-time setup fee of \$50 is required to establish the Midstate Money account.
- **Monthly Withdrawal:** The specified amount per membership tier will be automatically withdrawn each month on the first of the month, from the patient's debit or credit card on file. Please note that Care Credit is not accepted for monthly withdrawal.
- **Initial Term:** Members agree to an initial (6) six-month contract term with monthly billing as per the selected membership package.
- **Annual Term Renewal:** After the initial six-month period, membership contracts transition to annual terms, with a \$50 yearly membership fee to keep the account active.

3. Membership Cancellation Policy

- **Early Termination:**
- Membership cancellation may be requested at any time.
- Early cancellation within the initial six-month period will incur a **\$200 cancellation fee**, along with **payback fees equivalent to any membership discounts applied** to services during the membership period.
- **Annual Renewal Termination:** Cancellation requests after the initial six-month term are free from cancellation fees, but must be submitted in writing.
- **Membership Account Inactivity:** Memberships will be subject to termination after 13 consecutive months of inactivity, defined as the absence of any withdrawal from the account within this timeframe. Upon termination due to inactivity, a cancellation fee, as specified in the above policy will apply. For annual memberships where auto-draft has been discontinued due to non-renewal, any remaining positive account balance must be utilized within six (6) months. Failure to use the balance within this period will result in forfeiture of the remaining funds, If no activity, in the form of withdrawals, on your account for 13 months, membership will be terminated and you will be subject to the cancellation fee policy as listed above. If monthly auto draft has been turned off, and there is a positive balance on the account, you have 6 months to use the balance, otherwise the balance of your account will be forfeited.

4. Appointment Cancellation Policy

- Members are subject to Midstate Aesthetics' cancellation policy for any missed or canceled appointments without 24 business hours' notice.

5. Membership Commencement

- Membership benefits and contributions begin on the date of sign-up, once the initial payment and signed agreements are submitted.

6. Modifications

- Midstate Aesthetics reserves the right to adjust membership terms, pricing, and benefits. Members will be notified of any changes to their contract in advance, through your email on file.
